A MESSAGE FROM THE RECENT PAST-PRESIDENT OF OUR INTERGROUP BOARD, RENEE B.

Dear AA Members:

I would like to take this opportunity to thank you for your continued support of St. Paul Intergroup in 2005!

Intergroup relies on AA members like you to provide the services that help the still-suffering alcoholic. These services include maintaining a meeting directory, a list of temporary sponsors, a website, a list of people willing to do twelve-step work, a list of speakers, literature sales and most importantly a phone that is answered twenty-four hours a day and seven days each week. To accomplish all of these and many more services, St. Paul Intergroup relies on your donations, purchases and time.

During 2005, literature sales have declined. This is a trend that I feel is a responsibility of the Intergroup Board to point out to the AA community as a whole. The 2005 Intergroup Board was able to offset the deficit by cutting expenses, the biggest of which was the elimination of the answering service. This and other reductions helped to keep Intergroup "in the black" for the year. However, this has created an even greater need for the contribution of your time. Volunteers now answer the phone twenty-four hours a day and seven days a week, both during office hours and after hours. So far, the AA community has stepped up to the challenge: Along with the Night Owl coordinator, we have made sure the phones have not gone unanswered. Still, volunteers are always needed to make sure that whenever "anyone, anywhere reaches out for help," the AA hand is always there.

St. Paul Intergroup also follows the AA General Service Organization's lead in trying to keep book prices as low as possible. Here are some of the book prices:

Step Two: "Came to believe in a Power greater than ourselves to restore us to sanity."

What's it going to be, fear or faith?

When I went to my first meeting in January of 1986, I saw the twelve steps on the wall. Right away I noticed the second step. As I read the words in step two, I found myself in two dilemmas. One, I wasn't too keen about the term, "...power greater than ourselves..." which I thought was a religious reference. Plus, I couldn't make the connection with being restored to sanity. I wasn't insane; maybe you people were, but not me. Despite old timers taking me aside and explaining the difference between religion and spirituality, I was not letting go of my old ideas. The result was nil. That attitude kept in and out of AA for six years.

Then one night, two weeks sober, sitting in a Big Book meeting, I finally surrendered. I got a sponsor, Doug M., and began my journey into the steps. I was powerless, my life was definitely unmanageable, and I lacked faith as well. I had to have a spiritual experience to finally understand and accept step two.

I was pursuing a bachelor's degree at the University of Minnesota, running on self-centered fear and caffeine, when I had an assignment due, and the clock was ticking. I walked to class that day, terrified about not getting the assignment done and failing at school. My "committee" held an emergency meeting and decided I should just drop out, right then and there, and not tell anybody. Throw the backpack in a trash barrel and walk away. I knew how to quit school; I had done that two other times when I was drinking.

Then something happened.

I stood on the Washington Avenue Bridge, confused, panicking, and out of ideas. I remembered what the guys at my home group were talking about when they saw me at meetings. Whenever I brought up a situation that made me powerless or insane, they always asked me if I "prayed about it." At the time of my sobriety, I wasn't interested in that topic; I wanted to talk about sports or women, anything but spiritual principles. I finally became willing to try this "prayer thing." I walked over to the side of the bridge and said to the God of my understanding at the time, "I can't do this alone."

Some prayer, huh?

I went to class in a state of neurosis. The professor walked in and addressed us from the lectern. The first statement was, "I've decided to give you two more weeks on that assignment." I was shocked. I looked up at the ceiling, and acknowledged my fellow AA members. They were right. I had my first miraculous result and spiritual experience of turning my will and my life over to a higher power.

I was convinced. I raced home to tell Doug what happened that day, and he agreed knowingly, saying, "Oh yeah, it happens to all of us, it was just your turn today." Since that moment, I have come to believe in that power, which is the grace of God. I realized I was living my life on self-will and willpower. As the Big Book says in chapter four, WE AGNOSTICS, "Our ideas did not work. But the God idea did."

When it comes to taking the second step, the Big Book asks us one question: "*Do you now believe, or are willing to believe in a power greater than yourself?*" If we can answer yes, we are on our way. This power we are looking for is right inside us. We just need to tap into it via faith, and then get out of the way.

When the power steps in and takes care of me, I compare it to having a curb seat on a parade route. When I get fearful, I turn it over, wait patiently and watch the miraculous outcome right in front of me, and the best part is I'm not involved in the result.

My sanity is restored again.

4. Do I have to save face in group discussion, or can I yield in good spirit to the group conscience and work cheerfully along with it?
5. Although I have been sober a few years, am I still willing to serve my turn at AA chores?
6. In group discussions, do I sound off about matters on which I have no experience and little knowledge?

A Night Owl shift is a once-a-month commitment to answer phones during the hours that Intergroup is closed. Some shifts can be done in the office; all can be done from home. The commitment can be filled by an individual or a group. Taking on a Night Owl commitment means that when still suffering alcoholics call AA for help, they find another alcoholic at the other end of the line. When you or your group sign up to take a shift, you are trained in how to respond to calls and given all of the materials that are needed. **Please call the office or go to our website at www.aastpaul.org if you can help. 
