A MESSAGE FROM YOUR NEW OFFICE MANAGER, TOM N.

As the new manager of the St. Paul AA Intergroup office, I would like to thank the members and the meetings of Alcoholics Anonymous in St. Paul for my position. Of course, the best thing would be if Melissa were able to continue as manager, but that is not the case. Accepting this unfortunate circumstance of my beginning here, I would like to share with you my best understanding of what my job is, so that we can best work together. Let's start at the beginning, with a quote from the Big Book that is familiar to almost all of us. The first paragraph of Chapter 7 begins,

Practical experience shows that nothing will so much insure immunity from drinking as intensive work with other alcoholics.

It seems that this holds true not only for Twelve Step calls with newcomers, but with all kinds of service from setting up chairs before a meeting to answering phones at Intergroup and serving on the committees at the various levels of our service structure, as General Service Representative, etc. What are we doing at the various levels of service, as we work intensively together? Tradition Five tells us,

Each group has but one primary purpose – to carry its message to the alcoholic who still suffers.

Clearly, the first priority for Intergroup is help the new person find A.A. Every day we set up Twelve Step calls, find temporary sponsors to help with the transition from treatment to real-world recovery, locate meetings, and provide the literature that can be an important part of an alcoholic's first contact with A.A. In each of these things, we are also providing service opportunities for A.A. members who are already trying to stay sober. Intergroup is the place where the A.A. groups in an area pitch in together with phones and a website and other things to make it easy for the newcomer to find us. And the more we pitch in together for the newcomer, the more we provide each other with the service opportunities that keep us sober and improve the quality of our sobriety.

"Pain shared is half the pain; joy shared is twice the joy!" I believe my job in all of this is to encourage a positive attitude towards service work in the meetings that support Intergroup, as well as to provide as much service work as possible through the office.

This is in line with what the "Twelve Steps and Twelve Traditions" tells us in Tradition Eight,

Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers. ... The job [is] not to do Twelfth Step work; it [is] to make Twelfth Step work possible. (p. 166-168)

This is where we need your help. Right now, we have an excellent group of regular volunteers who answer the phones and talk to newcomers. During business hours, we have three shifts in the office: 9am to noon, noon to 2:30pm, and 2:30 to 5:30pm. After the office closes, phone calls are forwarded to our "Night Owl" volunteers. However, throughout the month of February we have had many daytime shifts that are not covered by volunteers. This means that phone calls from newcomers and others are being taken by the paid staff. It's our job to run the office, pay the bills, order literature and do the bookkeeping, but we would much rather that phone calls from newcomers be answered by unpaid volunteers, in keeping with the traditions. We feel that when we take these calls, we are depriving our members of a vital service opportunity. So, please help out if you can, and if you are not able to volunteer at our office, please spread the word and ask others to read this note.

Some years ago, I realized that A.A. is the place where alcoholics come to save our own lives together. In the beginning I was just trying to save my own skin and find a way to deal with my alcoholic soul-sickness that actually worked. Then, I could not see just how special our fellowship is; but now I do, and I deeply appreciate the privilege of serving as the Intergroup office manager.

TRADITION THREE

THE ONLY REQUIREMENT FOR A.A. MEMBERSHIP IS A DESIRE TO STOP DRINKING.

"This Tradition is packed with meaning. For A.A. is really saying to every serious drinker, "You are an A.A. member if *you* say so. You can declare yourself in; nobody can keep you out. No matter who you are, no matter how low you've gone, no matter how grave your emotional complications — even your crimes — we still can't deny you A.A. We don't *want* to keep you out. We aren't a bit afraid you'll harm us, never mind how twisted or violent you may be. We just want to be sure that you get the same great chance for sobriety that we've had. So you're an A.A. member the minute you declare yourself."

"Why did A.A. finally drop all its membership regulations? Why did we leave it to each newcomer to decide for himself whether he was an alcoholic and whether he should join us? Why did we dare to say, contrary to the experience of society and government everywhere, that we would neither punish nor deprive any A.A. of membership, that we must never compel anyone to pay anything, believe anything, or conform to anything?

The answer, now seen in Tradition Three, was simplicity itself. At last experience taught us that to take away any alcoholic's full chance was sometimes to pronounce his death sentence, and often to condemn him to endless misery. Who dared to be judge, jury, and executioner of his own sick brother?"

Step Three Essay

When I sobered up I was powerless, I ran out of options. I really wanted drinking to work for me. I tried drinking on the weekends, drinking once a month, I tried switching my alcohol beverages, and my main excuse was I WAS TOO YOUNG! After years of trying one last time I walked into the rooms of Alcohol Anonymous July 11, 1997. I threw up my hands, I was defeated and no longer had ideas. A man told me that I could do it, that I could stay sober, and be a good person. I had very little faith, but enough to light my way. I finally admitted powerlessness, and next, I knew I could no longer do it myself, so I let some one else. It's that old saying "I cant, she/he can, so I will let her/him." My will was to make drinking work for me and God's will for me was to have a better life.

Today in my life this is a step that I seem to have to come back to more than once. I am like they describe in the Big Book - the actor who wants to run the show. Constantly trying to manipulate things into the way I want them to be and when I don't get my way I turn resentful. My sponsor had me read this step in the twelve and twelve three times after my fifth step and the few thing that jumped out at me was that God can relive me of the obsession; whatever that obsession may be for the day. Also, while I was reading it I was thinking "Great - it's going to give me directions on how to do this." I was hoping that the directions would be really easy and tell me to do ten jumping jacks, or run around the room five times, after all it did say this is an action step. But it didn't say any of that, it said to pray for the willingness, be of service and work the remaining steps.

Minutes from January 17, 2006 St Paul AA Intergroup Representatives' Meeting

The meeting was called to order at 7:30.

The primary purpose of Intergroup was read.

The December minutes were approved following a change in syntax in the Web Site Report.

Treasurer's Report: Jeff T presented the treasurer's report. The December 2005 budget left us behind expectations in contributions, especially from groups. Sales broke even. The open position in our office saved money on salaries, but more was spent on insurance and equipment rental than was budgeted. Still in the black, December saw us almost \$800 below expectations.

A brief recap of 2005's expenditures showed that while Intergroup's income was lower than expected, careful spending still allowed us to come out several thousand dollars ahead for the year.

The Office Report: Tom, our new office manager, presented the office report. He's caught up on many of the loose ends caused by Melissa's absence. Medallions and literature are in stock and the office boasts a healthy number of volunteers at this point.

Website Report: Jonathan presented the website report. December saw heavier use of the site, with 50 more visitors per day than usual. The meetings of service entities were given their own page and Night Owl section has been cleaned up. The PDF meeting list will not be reinstated due to infrequent use. The office has a new computer and the fate of the old one is still being decided.

Outreach: District 8 is beginning a joint outreach program with Intergroup in order to educate more AA's about our functions and services.

Upcoming Events:

- New Years went well though there were questions about charging admission when the DJ is free.
- Women's Conference: Intergroup has been invited to sell literature at the conference and we are still looking for volunteers.
- **Night Owl Workshop:** Scheduled for Saturday, January 21, the workshop will train volunteers how to best answer the phones for Intergroup. With many shifts open, we hope word spreads of this simple service opportunity.
- **Tradition Workshop and Spring Fling** were both mentioned briefly, though no new information is available.

New Business:

An ASL Interpreter could cost Intergroup over \$1000 per year. We are looking for a volunteer to interpret for deaf Intergroup representatives.

A member volunteered to present concept two in February.

John presented the January mock reps report.

Closed with the Responsibility Statement and the Lord's Prayer.


Step Three Essay, continued from page 2
