STEP TWELVE: Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics, and to practice these principals in all our affairs.

For a long time, all I really heard when someone would recite the 12th step is the part about working with other alcoholics. Basically, I equated practicing this step with becoming a sponsor. I've come to learn that there is much, much more to this step, and I learned it by paying more attention to exactly how it's worded. Here are some of the things that stand out for me now:

"<u>Having had</u>" –I like the implicit assumption that if you've worked the first 11 steps, then you've had a spiritual awakening, period. I think Bill W., being the salesman he was, probably wanted to put the word "guarantee" in there somewhere.


"<u>spiritual</u> awakening as <u>the</u> result" – The bad news: You only get one thing from working the steps: a spiritual awakening. The good news: the spiritual awakening opens the door to a universe of happiness.

"we <u>tried</u>" – The word "tried" could have been left out and the step would still make sense, but I believe its inclusion carries an important messages for us alcoholics: we are responsible for the effort; our Higher Power is responsible for the outcome. We lead the pigeon to water; we can't make him drink.

"this message" – I always thought that the step read "carry the message," which I thought included all kinds of things: giving newcomers a copy of the Big Book, explaining the 12 steps, working the phones at Intergroup, etc. etc. And all these things are certainly important. But as written, what we're supposed to carry is "this" message, the message that we've had a spiritual awakening as the result of working the steps.

Incidentally, a recurring question from newcomers is: When am I ready to be a sponsor? I've heard a wide range of answers, like "If you're one more day sober than the new guy," or "As long as you're one Step ahead of your pigeon" or, often, some sobriety time qualification like "you've got to have a year of sobriety." It's said that the Big Book doesn't have an answer because it never mentions "sponsorship" by name. It occurs to me, however, that the wording of the Twelfth Step might provide guidance. When did the first 100 carry this message to other alcoholics? After they'd had a spiritual awakening as the result of working the steps. Of course, they would get through the steps in their first thirty days of sobriety; so waiting until then didn't hold them back much.

"<u>practice</u> these principles" – This part didn't make sense to me at first, since I always thought principles were things to believe in, not do. Then I came to understand that AA was a practical program of action, not beliefs, that our *daily* reprieve meant that our actions had to be taken on an *daily* basis, and that we "practice" them because we acknowledge that the best any human can do is "progress, not perfection."

"<u>all</u> our affairs" – I definitely started out in sobriety wanting to work the program cafeteriastyle: yes, I'll have some Humility and Courage, but "maybe later" on the Honesty. It took awhile for me to understand that not only would half-measures avail me nothing, but three-quarters measures didn't do much better. "All our affairs," I came to believe, is the flip side of "go to any length."

So now when someone reads the twelfth step, this is what I hear:

HAVING HAD a **SPIRITUAL** awakening as **THE** result of these steps, we **TRIED** to carry **THIS** message to other alcoholics and **PRACTICE** these principles in **ALL** our affairs.

Tradition Twelve: Anonymity is the spiritual foundation of all our traditions, ever reminding us to place principles before personalities.

The September minutes were approved pending the deletion of a paragraph on non-conference literature.

Treasurer's Report: All contributions for September were well above budget. We received a \$3,210 donation from Gopher State Roundup. September Contributions (Group, Faithful Fivers, and Special) \$7,539 – 62.1% of Income. September Sales 4,603 – 37.9% of Income also were above budget. Group contributions \$3,779 – 549 meetings listed on website (41 Groups Contributed for September, and 137 for 2006. Expenses were greater than budget due to Accounting fees, Upgrade of copier, Building Liability Insurance, and Payroll is up due to turn over of staff. Conferences expense is for Hotel and Seminar fees for Office Manager to attend Intergroup Managers conference in Ohio. Manager did not attend last year so budget was not set up.

The Office Report: Tom delivered the office report for September. Tom visited Akron, OH where he attended the annual seminar for Intergroup office managers. He felt this need for office manager 'self care' to be very important. He learned a lot of alternate methods of fundraising there. As always, there are a plethora of service opportunities available at the office.

Website Report: Jonathan was not available to present the September website report.

Outreach: Alfred was not available to present the September Outreach report.

Night Owl Report: Dianne presented the September night owl report. We have three shifts open now. Dianne will be promoted to Night Owl Coordinator at the end of the year and will need a new assistant. Night Owl holds an orientation for new operators on the third Saturday of every month in the Intergroup office.

Vote on Non Conference Literature Tonight was the final vote on whether or not to include non-conference literature in the office. It took five ballots to decide, with few changes on each round. The final vote was that we would not be incorporating materials and literature that are not approved by the general service conference. We would like to thank the groups of Saint Paul for their interest and involvement in this debate. It's the groups we serve who make it possible for us to run Intergroup.

The Twelve Concepts: Concept XII

General Warranties of the Conference: in all its proceedings, the General Service Conference shall observe the spirit of the A.A. Tradition, taking great care that the Conference never becomes the seat of perilous wealth or power; that none of the Conference Members shall ever be placed in a position of unqualified authority over any of the others; that all important decisions be reached by discussion vote, and, whenever possible, by substantial unanimity; that no Conference ever be personally punitive or an incitement to public controversy; that though the Conference may act for the service of Alcoholics Anonymous, it shall never perform any acts of government; and that, like the Society of Alcoholics Anonymous which it serves, the Conference itself will always remain democratic in thought and action.

Therefore we expect that our Conferences will always try to act in the spirit of mutual respect and love — one member for another. In turn, this sign signifies that mutual trust should prevail; that no action ought to be taken in anger, haste, or recklessness; that care will be observed to respect and protect all minorities; that no action should ever be personally punitive; that whenever possible, important actions will be taken in substantial unanimity; and that our Conference will ever be prudently on guard against tyrannies, great or small, whether these be found in the majority or in the minority.

The sum of these several attitudes and practices is, in our view, the very essence of democracy — in action and spirit.

Freedom under God to grow in His likeness and image will ever be the quest of the Alcoholics Anonymous. May our General Service Conference be always seen as a chief symbol of this cherished liberty.

New from the AA Grapevine — Emotional Sobriety: The Final Frontier

The following excerpt from Bill W's 1958 essay is the introduction to this new book.

I think that many oldsters who have put our AA "booze cure" to severe but successful tests still find they often lack emotional sobriety. Perhaps they will be the spearhead for the next major development in AA — the development of much more real maturity and balance (which is to say, humility) in our relations with ourselves, with our fellows, and with God.

Those adolescent urges that so many of us have for top approval, perfect security, and perfect romance — urges quite appropriate to age seventeen — prove to be an impossible way of life when we are at age forty-seven or fifty-seven.

Since AA began, I've taken immense wallops in all these areas because of my failure to grow up, emotionally and spiritually. My God, how painful it is to keep demanding the impossible, and how very painful to discover finally, that all along we have had the cart before the horse! Then comes the final agony of seeing how awfully wrong we have been, but still finding ourselves unable to get off the emotional merry-go-round.

How to translate a right mental conviction into a right emotional result, and so into easy, happy and good living — well, that's not only the neurotic's problem, it's the problem of life itself for all of us who have got to the point of real willingness to hew to right principles in all our affairs.

Even then, as we hew away, peace and joy may still elude us. That's the place so many of us AA oldsters have come to. And it's a hell of a spot, literally.


