## **STEP ONE:**

## We admitted we were powerless over alcohol - that our lives had become unmanageable.

In the *Twelve Steps and Twelve Traditions* book, Bill W's chapter on Step One is about defeat and humiliation. Step One is us admitting what most of the people in our lives already know, that we are utterly defeated. Being ready to take Step One is a gritty, nasty, awful place, which can be accompanied by jail, hospitalization, physical pain, self-hatred, loneliness (real or imagined), fear, homelessness, poverty, anger, sadness, confusion, or as is many times the case some combination of all of these things and more. Step One feels very bad initially, or at least it felt very bad to me.

What we don't realize at first is that without our acknowledgement of powerlessness we cannot begin our journey toward healing. When I was finally ready for step one, I was broke, sick, lonely, pathetic, jobless, virtually friendless, way too skinny and I hated myself. I was totally defeated and willing to do anything to feel better. It was a very painful place but, only then was I willing to reach out for help and take an honest look at my life.

A few years later I am able to look back on that time as an opportunity for growth and recovery. In this program I have learned that pain isn't just pain, it's a gateway for change. If I'm willing to go through the pain, despite the fact that it hurts, I am given the gift of some inner peace and personal growth. When I was unwilling to acknowledge or deal with my pain, I was missing out on opportunities to become a better more satisfied person. Step One is the first step we take for a reason, without it we cannot truly begin.

#### <u>Tradition One</u>: Our common welfare should come first; personal recovery depends upon A.A. unity.

What exactly is the common welfare that AA looks for? I believe that it is that drive to be happy, joyous and free. When we come together to look for these things, we are bound by our journey to search for this welfare. This tradition speaks of a common welfare and not that of one or two AA's. Without the unity of our fellow members, we would be left with our own attempts at personal gain that we alcoholics are so good at. The unity implies a responsibility of everyone of us to pull together to aim for our real purpose, helping another alcoholic. How paradoxical it is that one's personal recovery depends on AA's unity. Of course, our own experience has shown us that we can not stay sober on our own. We need other AA's to rely on. A large appeal of AA, and also the most frightening for newcomers, is the solidarity of any meeting we attend. "How," they ask, "can such a crowd of anarchists function at all? . . . What in Heaven's name holds them together?"\* When we remember what brought us to Alcoholics Anonymous, the shame and desperation; we should delight in the unity of AA. We can then gladly place this common welfare first that any alcoholic seeking our happiness may discover his own personal recovery.

# <u>Concept One</u>: Final responsibility and the ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

Until the early 1950s, Bill W. and Dr. Bob made all the major decisions for A.A. as a whole. At the local level, many of the groups relied on Bill and Dr. Bob when questions arose on how to run the group, or about A.A. service activities.

When Dr. Bob became terminally ill, Bill saw that A.A. needed to become self-sufficient to prepare for the inevitable day when the founders would be unable to give their advise. The A.A. General Service Conference was created as the decision-making body for A.A. as a whole. The General Service Conference is made up mostly of Delegates from all of the Areas of the U.S. and Canada, along with the General Service Office staff, the *A.A. Grapevine* staff, the Trustees of the General Service Board, and the Corporate Directors of A.A. World Services and The A.A. Grapevine, Inc.

At the St. Louis International Convention in 1955, world service responsibilities were transferred to the General Service Conference, which today meets annually to express the collective conscience of A.A. as a whole.



## Is your meeting represented at Intergroup?


