## Step Twelve: Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs.

My friend, Norma, came to AA at the age of sixty-two. She has been sober for twenty-four years.

Norma and I fit the phrase: "We are people who normally would not mix." We are from different generations and backgrounds. Yet, we enjoy each other's company at AA meetings and other outside activities.

In sobriety, Norma has faced many physical infirmities, including Parkinson's Disease, a heart condition, and macular degeneration. But, as her physical condition deteriorated, Norma's spirituality seemed to increase. She faced each setback with grace and dignity, ever grateful for the simple things in life and appreciative of what she perceives as God's continuous blessings.

When I hear complaints about things that seem trivial, I think of the courage she exhibits. Now confined mainly to home, Norma is an example of grace under pressure. There are many ways to share experience, strength, and hope in our program. Norma shares hers by example.

### Tradition Twelve: Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles before personalities.

In the beginning there were two drunks. Through what many in the AA community believe is Divine intervention, these two drunks found each other in Akron, Ohio and found a (not the only) solution to alcoholism. This has happened before. In 1840 a group of drunks got together, called themselves the Washingtonians and came up with a solution to their problem, but in the long run, their egos got involved. It was more than sixty years before that combination of circumstances repeated itself and what is now AA was born.

Washingtonians at their peak numbered in the tens of thousands, possibly as high as 600,000. However, in the space of just a few years, this society disappeared because they became fragmented in their primary purpose, becoming involved with all manner of controversial social reforms including prohibition, sectarian religion, politics, and abolition of slavery. Their extinction was so complete that Bill and Dr. Bob had never even heard of them when they stumbled across the formulation for AA.

Recently there have been some individual anonymity breaks by well meaning reporters who think that breaking their anonymity will help more people; including one that questioned whether we even needed anonymity any longer. This is not the case. What they believe is help is really a desperate cry for attention -- a cry of their egos that could make our current fellowship as extinct as the Washingtonians.

The Twelfth Tradition is not about protecting our ability to live in fear because we think no one knows we were drunks. Everyone knew that we were drunks, and they'd known it for years. The Twelfth Tradition is about having something bigger than you are - something that you can help grow and nurture without having to take credit for it to feed your ego. Anonymity protects the fellowship by allowing newcomers to arrive in the rooms without having to solve their fears until they are ready to take the actions in the Twelve Steps to solve their problem.

Then, if they have good sponsorship, they realize that their anonymity isn't about hiding from people that knew they were horrible drunks; it's about making sure that if they slip and create new wreckage that it doesn't damage The Fellowship's ability to tell others that recovery is possible and the rooms are open for those who come looking for a solution.

Many people are confused about anonymity, but the concept is really quite simple. You should be anonymous to public groups of people, not in the fellowship, not in the rooms, and not privately with another person who may need to know that there is someone they can talk to; if they, or a loved one, needs a solution. In public, including the Internet, you can say that you are a recovered or recovering alcoholic, but you cannot say that you are a member of Alcoholics Anonymous. Remember that if you say publicly that you are a member of AA, and God forbid, relapse, then you just planted the seed that AA doesn't work, and that might just prevent someone who needs the solution from reaching out his or her hand.

Bill Wilson's obituary said it perfectly: "In fathering the doctrine that members should not reveal their AA affiliation at the public level, Bill W. had explained that `anonymity isn't just something to save us from alcoholic shame and stigma; its deeper purpose is to keep those fool egos of ours from running hog wild after money and fame at AA's expense.' He cited the example of a nationally known radio personality who wrote an autobiography disclosing his AA membership and `then spent the royalties crawling the pubs on West 52nd Street.'"

And from the long-form of Tradition Eleven, "There is never need to praise ourselves. We feel it better to let our friends recommend us."


