## Step Nine: Made direct amends to such people wherever possible, except when to do so would injure them or others.

#### "Amends - noun, (used with a singular or plural verb) 1. reparation or compensation for a loss, damage, or injury of any kind; recompense."\*

In my drinking days I was responsible for many an injury, damage and loss, which inevitably separated me from friends, family, and anyone else who crossed my path directly or indirectly when the tornado of my disease was in full flight. As I reflected on my Eighth Step list, I saw the carnage - emotion, mental, physical, financial and spiritual - that swept away what I treasured most: a sense of place and purpose in life; most especially the vital relationships with my friends and family. The havoc and destruction were all there spelled-out in black and white. No "what ifs" or "yeah buts" could excuse my actions. It was time for me to go out and set-right, to the best of my abilities, years of hurt feelings, damaged relationships; not to mention the lost time, money, and energy that my selfishness and self-centeredness had wrought upon the world, my friends and family.

My sponsor, having heard my Fifth Step, help to set my priorities, knowing full well my old inclinations to avoid the hard tasks in preference for half-measured & half-hearted efforts; he suggested that I go straight out and make the "hardest" amends first. I am so glad I followed his suggestion, for little did I know the gift that would come of it.

And so I found myself before my father. Here was a man I had hurt emotionally, damaged in innumerable ways, and for whom I had caused uncountable financial loss on each occasion that I turned to him to bail me out of a jam. To my father I said that what I had done to him was wrong, pure and simple. I told him that rather than be the son I always wanted to be for him, I had chosen, instead, to be a manipulative, thoughtless, selfish, inconsiderate, self-seeking and greedy kid, whose only interest was in getting what I thought I deserved, regardless of the cost to him.

I told my dad that he did not deserve to be on the receiving-end of such unconscionable behavior. I shared with him that I was taking a new approach to life through the program of Alcoholics Anonymous. I then told him that through A.A. I had come to realize that a life based on selfishness and self-centeredness was hardly estimable. From now on, I would try, to the best of my abilities, to set my life on a difference course, where the needs of others outweighed the needs of my own. I asked my dad how I might set things right with him, to <u>his</u> satisfaction.

His answer was simple and clear: check your motives, count your blessings, and give of yourself without regard to what you might get in return. Then he hugged me and told me that he was proud of me.

For the next six years, I got to know my father in a whole new light. As the years passed and he began to be crippled by Alzheimer's, Dementia, and Parkinson's disease, he demonstrated to me the principles by which he suggest I live my life. I came to see that they are the same principle the A.A. programs asks me to practice and live by.

Five years ago, as he lay in hospice, edging in and out of consciousness, I was by his side, holding his hand. There was a moment when he came into full consciousness and I said to him, "I love you." From the depths of his soul, he replied: "I love you;" words he had rarely expressed to anyone. Those were his last words to me. He passed peacefully a week later. I am eternally grateful to A.A. for helping me to find my purpose and place in life by amending the damage caused by my active alcoholism. Thank you A.A.

## Tradition Nine: A.A., as such, ought never be organized; but we may create service boards and committees directly responsible to those they serve.

"A.A...ought never be organized." As a newcomer I welcomed anything that relieved my aversion to anyone being in charge. Like many alcoholics, I had no desire for anyone to tell me what to do. But I was confused, people greeted me at the door, the meeting room was set, the coffee was made and there was somebody leading the meeting..."she must be the president", she must be in charge.

As time went by I came to realize that there was organization in A.A., there had to be. At my Homegroup I learned that we had business meetings every month, that there were jobs that needed to be filled. My sponsor "suggested" that I attend the next month's meeting and get a job. My ego led me to believe that I would be perfect as the meeting chair...I heard that the "president" was rotating out – whatever that was. So I made that meeting and for the next two months I was in charge...of cleaning coffee cups and ashtrays. My point is there had to be organization to insure the meeting was up and running every week. Later I learned that the organization was to be the least possible and that no one was in charge.

But if there wasn't a "president" or a "grand poobah", how did all the important decisions get made? Not just the decisions at my little home group, but in A.A. as a fellowship, around the world. Who decided whether we were to be an "open" or a "closed" meeting? Who decided if we would publish a 4<sup>th</sup> edition of the Big Book? Who decides how we will participate in social media? The fellowship decides...but how? It happens through the group conscience; the group conscience of the Tuesday Night Big Book meeting, or the group conscience of the Area Assembly., or the group conscience of the General Service Conference. All groups are created to insure that the thoughts and ideas of the fellowship are communicated from the smallest of groups to the General Service Office of A.A. In New York.

It was "suggested" that I get involved in general service...and I did, at the district, area and my local Intergroup office...and I learned that these groups were there to insure that A.A. continue to grow, that A.A. remain strong, so that the future of A.A. be insured for us and those to come in the future.

I learned how the meeting lists were constantly updated, how the phones were answered, so that the suffering alcoholic would have someone to talk to in their time of need. I learned about everything needed at our General Service Office, from committee desks to editors, accountants to trustees. How we entrust our delegates to travel to the General Service Conference each year to make the decisions regarding the future of Alcoholics Anonymous.

While organization exists in A.A., it doesn't rule, judge or govern. Our GSO assumes the responsibility of the day to day operations of A.A., but does so with the guidance of the delegates and trustees – elected in the "spirit of service" and built through the concept of rotation. Rotation insures that all positions and jobs, from greeter to GSR, coffee maker to delegate, be functional but temporary. I know that whatever position any of us hold, it's for this rotation – and this just happens to be my turn.

They do not govern! Most of us have been raised in an environment where the leaders are in charge, that they make the rules and enforce them. For those of us with huge egos, the powers of position have lured us in like a moth to the flame. I learned in A.A. that there were no positions of power. That to serve the fellowship I must leave the ego at the door and welcome my higher power into the room.

As it says in the 12 & 12, "It is clear now that we ought never to name boards to govern us, but it is equally clear that we shall always need to authorize workers to serve us."

At the first meeting, I was very confused and didn't understand much of what was happening. I had been to many AA meetings but not an Intergroup meeting so this was very new to me. As an Intergroup Representative, I learned that the Intergroup meeting is formally called the "Saint Paul Intergroup Council meeting" and that "all groups are urged to send a representative to this meeting". At these meetings we conduct the "business" of AA: making sure the phones are on, the website is up-to-date, the groups voice is heard, the office is running well, etc. In other words, the Intergroup Board (and Council) serve the AA groups. I kept coming back and "fell in love".

## AA Grapevine's Chief Executive

For three quarters of a century, the AA Grapevine has been the fellowship's "Meeting In Print", begun in 1944 by an all-volunteer staff of "ink-stained wretches". Bill Wilson quickly saw it as a powerful communications tool as a co-founder and defacto leader of AA, and used it many times until his death in 1971. In fact, all of Bill's articles can be found in the AA Grapevine book, <u>Language of the Heart</u>. Today, the book is printed in multiple languages, large print, hard and soft cover, and recently a price change was made for the audio version, down to \$9.99 as a download.

The AA Grapevine, Inc. is one of the two affiliate corporations of the General Service Board (GSB). Bill writes extensively in the Twelve Concepts of World Service the need to allow this voice of AA members to operate independently. It has a net positive contribution to the GSB's Reserve Fund, so over time it has been fully self-supporting. In fact, that is one of the key responsibilities of the Board of Directors and the Chief Executive of AAGV – to always be self-supporting through its magazine subscriptions and associated items.

In that vein, the AAGV has embarked on a 3-year strategic plan to vision and plan to maintain the financial viability of this affiliate corporation. While not part of this plan, AAGV has recently hired a new chief executive, Albin Z. This was a marvelous, outstanding opportunity for AAGV to acquire this talented individual. With a lifetime employment history almost exclusively in publishing, followed by a stint of being a General Service Trustee (GST) for AA and sitting on the AAGV corporate board plus a couple years of experience as Director of Administrative Services at the General Service Office, AAGV stands to greatly benefit from this cumulative experience.

In a conversation with Albin, his managing philosophies – congruent with our Concepts – became apparent. It starts with the new position for which he was hired, "Publisher", which was formerly Executive Editor. Albin feels that with a senior editor already on staff, the active responsibility and authority should match (Concept 10). It seems most reasonable that the chief executive should insure things are published correctly, not edited correctly, since the editorial function has been clearly defined. Additionally, in this multi-media world, it is imperative that AAGV explore the myriad of publishing options available, and that is on the top of Albin's task list. The unique blend of his overall work experience is formidable. No doubt, in a world that has overall seen printed materials decline in popularity, Albin factors in these social trends but just as quickly utilizes data more relevant to AA members' behaviors and finds the mix that fits the fellowship.

In wise business fashion, Albin has also made a change in another senior position. With an office of less than 10 people, having a full-time controller was becoming increasingly untenable and AAGV has opted to author a shared services agreement with A.A.W.S., which will simultaneously cut expenses measurably while tapping the depth of skills in the corresponding department in their sister affiliate.

Utilizing the 2018 Strategic Plan authored by the directors of AAGV last year, Albin has a clear definition of the strategic direction the Board of Directors has for the Grapevine corporation. With technology so integral to content delivery -- AAGV App, audio recordings, eBooks, to name a few – Albin has brought a new web site using Drupal 8 (latest programming language) over the finishing line, and a new wireframe for a site re-write has already been authored. The *La Vina* stories have recently been digitally archived. Simultaneously, collaboration with A.A.W.S. to have a unified shopping cart and getting AAGV onto the new Netsuite ERP system is in the works. With AA rolling out a new mobile app with Meeting Guide as a base, plans to incorporate AAGV into the app are on-going. All this work is paying off: www.aagrapevine.org has reached the highest traffic numbers it ever has had in history.

A new catalog has just been printed, and all three languages of our conference structure, English, French and Spanish, have their sections in the catalog. It's a virtual work of art – likely the most impressive, user-friendly, inclusive catalog AAGV has ever delivered. Speaking of languages, a new shopping cart for Spanish products has been rolled out – and the site is all in Spanish (it wasn't before!).

Integral to AAGV is a full operation to produce another bi-monthly periodical, the *La Vina*. This is a Spanish AAGV, separately edited and produced. Started in 1997, the fellowship made the decision in 2001 that it is vital to have the magazine for the Hispanic community, and since that time all costs above the profits generated by the sale of *La Vina* are paid for by the Reserve Fund, per Conference Advisory Action. So, Albin has the responsibility to insure the publishing of this second periodical.

In 2018, the Conference recommended that the AA Grapevine, Inc. begin to sell its items beyond A.A. groups and individuals. With that in mind and with approval by both affiliate boards, non-AA customers of A.A.W.S. are now being contacted by AAGV to develop additional sales for AAGV. This effort parallels the mission of AAGV, which is to provide information to all people interested in alcoholism, not only A.A. members.

AAGV generates a harmonious melody of recovery with the "voices of A.A.". AAGV both belongs to and reflects the A.A. fellowship, and the efforts of the AAGV Board of Directors, the management and staff, and the A.A. fellowship can resonate throughout our conference structure in vibrant fashion, carrying the fellowship's message of recovery, unity and service.
