## THOUGHTS FROM THE BOARD

Greetings to all this February which is often known as, "heart month."

One of my favorite pieces of AA literature comes from Bill W.'s March 1962 article to the Grapevine on, "This Matter of Acceptance." In this article are two sentences that have made a great impact on me and how I try to live my life in sobriety. It starts like this, "I try hard to hold fast to the truth that a full and thankful heart cannot entertain great conceits."

It is with this feeling in mind and, "attraction rather than promotion," from some AA friends that I decided to stand for a seat on the St Paul Intergroup Board and was elected. Having sobered up in Central Minnesota where there was no such thing as an, "Intergroup," it was an area of service I had not had opportunity to experience. Indeed, I wasn't sure where it fit in to the whole service structure, having been raised with the upside-down triangle that included groups, districts, and area services. Knowing that past service had help me to grow in my program of recovery and having been on a very, "long," hiatus from service work due to some sad life eventsthis seemed through the attraction mentioned above, to be the direction that my Higher Power was leading me at this time.

In January, I participated in an Intergroup training for current board members that was also designed to help orient new members to the board. During this training, current officers and our Area 36 Alternate Delegate presented information on everything from parliamentary

procedure, (important for us in AA as we can be an unorganized lot.), Intergroup's bylaws, financial reporting, articles of incorporation, various committees within the board and interestingly enough, how Intergroups fit into the service structure of Alcoholics Anonymous. Imagine that.... This question was answered for me! There was lots of information to learn.

When we were reviewing the bylaws - which can be a bit dry, but so very necessary I have found, for steering committees and Intergroups as well -I noticed an interesting item in one of them. That item was that, if a member group wants to call a special meeting of Intergroup due to a concern, they can do so. It would be done in the following manner:

3.2 Special Meetings: Special meetings of the Member Groups through their Representatives may be called at any time (a) by the Chair, (b) by the Board or (c) upon written request of at least eight Representatives or ten percent (10%) of the total registered Representatives of the Corporation, whichever is less. A request to call a special meeting of the Member Groups must be made to the Chair in writing, and the Secretary shall then give notice of the meeting setting forth the time, place, and purpose thereof, to be held no later than 90 days after receiving the request. If the Secretary fails to give notice of the meeting within 30 days from the date on which the request is received by the Chair, the person or persons who requested the meeting may fix the time and place of the meeting and give notice thereof in the manner hereinafter provided. If a special meeting is demanded by the Member Groups, the meeting shall be held in the county where the registered office is located. The business transacted at a special meeting is limited to the purpose stated in the notice of the meeting.

## JUST ANOTHER MIRACLE

I shouldn't trivialize a miracle with the word 'just.' Each is amazing and deserves real honor. When I think about what our Higher Power does each day to provide life and recovery for all of us, I am filled with gratitude and overwhelmed with awe. So, when the AA community of St. Paul Intergroup came through with enough contributions to not only balance the budget but provide a sizeable surplus, I thought, "JUST ANOTHER MIRACLE."

In November, the treasurer put together a forecast that said St. Paul Intergroup would likely have a \$15,000 shortfall. Those of us on the board were worried and rightly concerned. We were hiring a new Office Manager who deserved a reasonable wage and to keep in the traditions, we should offer one. In a past life, I might have stayed stuck in fear. Instead, the board leaned into prayer and focused on what God would have us do.

The first necessary thing was to let the groups know. We shared the projected shortfall at the Reps meeting. We also created a brochure that highlights how to financially support St. Paul Intergroup with a QR code to make it easier to contribute. (the QR code is on page 3 if you are interested). We had an excellent turnout for Gratitude Night, and we took that opportunity to inform AA members further of the current financial need

In the following weeks, we saw a miracle happen. Gratitude Night, we had several contributions—more than enough to cover the expenses of the meeting with a nice cushion while an increased trickle of contributions entered the office. As we entered December and the discussion of Intergroup's financial need spread through the community, that trickle became a flow. At that stage, our treasurer became confident we would meet the budget. By year-end, the flow was a steady stream, and we ended the year with a surplus of over \$5,000.

You helped to create another miracle, and we thank you! The board also recognizes that you voted with your dollars, telling us St. Paul Intergroup matters to you. Each one communicated that you value this service and want it to remain, and

the vitality of Intergroup is something the AA community relies on.

As a result, the board is committed to making Intergroup even more vibrant for you. In addition to the two ad hoc committees of Night Owl and Outreach, we've added a third–Expansion. The goal of this committee is to 'expand' usefulness and reach in the AA community. At the core, Intergroup is here because of you and for you. You, and every other alcoholic like you, are the most important part of this process. As we've seen in every miracle within AA, the more we rely on each other, the more promises are fulfilled, and the greater number of drunks we can get off a bar stool and into the rooms.

If you are wondering what you might do to get involved in these miracles, here's a list of things to consider:

## STEP TWO

Came to believe that a Power greater than ourselves could restore us to sanity.

#### A CLOSE CALL AT THE WEDDING

During my initial two months in AA, I had great difficulty with Step Two, which I referred to as "that Higher Power thing." I took my sponsor's suggestion and made the Manhattan Group of AA my Higher Power, but privately, I knew that wouldn't work. Eventually, I went along with the "Group of Drunks" G.O.D. concept. I "acted as if" I had a Higher Power because I wanted to make my sponsor happy. But I didn't believe in God.

I got away with my non-belief until the wedding of my favorite relative, Aunt Ethel. I knew a wedding reception was not the best situation for a recently sober alcoholic. But I also knew that my absence from the event would not improve my already shaky standing with my family. I had two significant concerns. First, the wedding reception venue was in the middle of nowhere in rural Long Island. Not having a car meant a family member would have to drive me to and from the event. I wouldn't have the freedom to leave whenever I might need to. Second, a crowd of partying wedding guests in various stages of getting plastered would severely threaten my newfound sobriety. If ever there was a time to seek my sponsor's experience, strength and hope, it was now. Though he cautioned me to avoid situations where alcohol might be involved, he developed an excellent plan for handling a wedding party.

Back then, there were no cell phones. My sponsor told me to bring my list of telephone numbers and a pocket full of quarters. Then, when I arrived at the venue, I should find the pay phone and call him. Additionally, I should call him or another AA member on my list during the reception if I felt uncomfortable. I was in awe of his wisdom.

On arrival, I found the pay phone downstairs by the bathrooms. But to my horror, a "Sorry, Out of Order" sign was taped to the phone. In a panic, I found the manager and asked if there was another phone. No, there was not. My heart sank. I felt doomed, as doomed as doomed could be.

The wedding guests were drinking, dancing to loud music and having a great time. And the open bar was serving drinks for free. Now I felt like I was on a ship sinking fast and there were no lifeboats. The only thing I could do was say a prayer to this so-called Higher Power who had put me on the Titanic! I closed my eyes and spoke a sarcastic prayer. "OK God, who is not of my understanding," I prayed, "if it is at all possible, please help me not drink. Please, help me. Please."

Almost immediately, it became evident the prayer wasn't going to save me, as cousin Larry, my former family drinking partner, approached with a big grin on his face. I prepared for the worst. As usual, Larry enthusiastically shook my hand as I asked how he was doing. Larry shrugged his shoulders and said he was fine. But I knew what was coming next. Larry would insist we move to the open bar and get some of that free booze. Again, I would be utterly defenseless. Then he said something entirely unusual.

"I gotta tell you that I'm kind of doing things differently now," he said. "I'm taking things one day at a time."

#### What?

For a brief moment, I became alert. Could it be? No, not very likely. I decided to throw out a program slogan and see his reaction. "Me too," I said. "I'm kind of taking first things first." Larry's eyes got big. He tilted his head. "Do you mean, like, you're keeping it simple?" he asked. "Um, yeah," I said with a smile. "Like live and let live."

We looked at each other in amazement. Larry swallowed hard before he spoke. "How long have you been a friend of Bill?" he asked. "Only 60 days," I answered. "How about you?" Larry replied, "Counting 58 days today!" Larry leaned closer and in an anxious voice whispered, "The pay phone is broken." I whispered back, "Yeah, I know."

We both suddenly realized what an incredible stroke of luck we were experiencing. Without hesitation, we gave each other a big hug. "Come on," Larry said, "let's move to the open bar and get some free ginger ale in champagne glasses for when we have to toast the bride."

Larry and I stayed together and made it through the rest of the reception sober and grateful. When I returned home, I immediately called my sponsor and told him the story. He remained silent for several moments before he spoke. "How might you account for such a fantastic coincidence?" he asked. "I don't know," I answered. "Pure luck, I guess."

My sponsor paused for a moment. "In the last couple of months, you've been lucky more than once, haven't you?" he said. I hadn't thought about that, but he was right. I'd had several bouts of luck recently. Once again, he remained silent and then asked a powerful question. "Could it be that what you think of as luck really isn't luck at all? Maybe it's something much larger."

His words had a profound effect on me. A sudden, bright light illuminated the darkness where I'd lived most of my life. After that, everything began to make sense. I came to believe beyond any doubt that my Higher Power had brought me through the doors of AA, kept me sober for almost two months and even answered my sarcastic wedding reception prayer. Of course, my Higher Power had always been there, but until now, I just hadn't seen it.



## TRADITION TWO

For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

### SPEAKING UP

I was raised in an alcoholic household. My father was an alcoholic and my mother should have been in Al-Anon. While I was growing up there was always a big elephant in our living room that no one ever talked about. Many times my father came home drunk. He did not help with household chores, he neglected family obligations and was sometimes verbally abusive.

I never felt as though I had permission to talk about what was bothering me. My mom always said that I shouldn't allow my dad's behavior to bother me. But it did. She told me to let what my dad said "go in one ear and out the other." But that's not how it worked for me. His words went in one ear and stayed inside me and never got processed in a healthy way.

I had difficulty forming close relationships, as I could not bring myself to tell friends what was really going on inside me and in my home. I was unable to tell people how I felt.

When I got to AA at 28 years old, I remember trying to verbalize what was really going on inside my heart. It was so difficult for me to do this that I actually experienced pain in my throat when telling my fellow AA members how I felt. This "stuff it" defect of character, my inability to speak about how I felt and what I thought, caused problems in my relationships with friends, as well as in romantic relationships. This defect kept me from being close to those around me. And that is what I craved: a closeness and companionship with others.

I worked on that issue with my AA sponsor, and by working the Steps I learned that this defect of character is rooted in fear. I sought outside professional help and learned a new truth for me, which is this: I have a right to

let family members know when I'm concerned or upset about something. In fact, it's a good thing to voice my opinions or perspective in a healthy and sensitive way. I keep this new truth written down and carry it with me in my purse.

Recently, I have felt uncomfortable with gratuitous use of profanity and cross talk at my home group AA meetings. After one of these meetings, I told an AA friend, Cheryl, that I did not think that this is the way our group should act during meetings. I told Cheryl that I might just go to meetings at a different location instead of making it an issue. That was my old way of doing things, walking off like I've always done without addressing the problem.

"No," Cheryl said, "you need to bring this issue up at the next group conscience meeting." She was tired of the cross talk at the meetings too. I talked with my sponsor about the issue and she encouraged me to bring this up at the group conscience meeting as well.

I reread AA literature about the Second Tradition in Twelve Steps and Twelve Traditions and in The Language of the Heart. Although I did feel uneasy and it took courage to act, I did bring it up at the next group conscience meeting. Turns out, many people at the meeting had the same concern about cross talk and language used at our meetings. The members of the group conscience were supportive and we had a healthy discussion. Motions were made to help reduce or eliminate cross talk and will be voted on at the next group conscience meeting. However not everyone felt the way I did, and I was able to listen to other points of view.

It does not matter so much about the outcome of this particular matter. What's important is that AA provides a safe place for us to voice our opinions. I have learned in AA that I'm in charge of the footwork and God is in charge of the outcome. I need to do my part (speaking up) and then trust God in the results department. A loving God as he may express himself in our group conscience means I need to show up, get over my personal hurdles and speak up as best I can. I now know that what I say matters, it really does. I trust that God is in charge of the rest.
